## **INVITATION TO BID/REQUEST FOR EXPRESSION OF INTEREST**

The PNP PRO 8 through the GOP through SARO BMB-D-15-0000898 dated 9 February 2015 funds intends to apply the sum stated below being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair of Libagon MPS Building Project. Bids received in excess of the ABC shall be automatically rejected at bid opening.

### **REPAIR OF LIBAGON MPS BUILDING**

Bidding shall be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act of 2003. Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizen of the Philippines.

Interested Bidders may obtain further information from the PRO8 BAC Secretariat, Office of the Regional Logistics Division (ORLD), Camp Kangleon, Palo, Leyte and inspect the Bidding Documents from 8:00 AM to 12:00 Noon and from 1:00 PM to 5:00 PM.

A complete set of Bidding Documents shall be issued to interested bidders at PRO8 BAC Secretariat, ORLD and upon payment of a non-refundable fee for the Bidding Documents to be paid at the Regional Finance Service Office 8. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and website of the Procuring Entity, provided that the bidders shall pay the fee for the Bidding Documents not later than the deadline for the submission of their bids.

The PRO8 BAC shall hold a Pre-Bid Conference which shall be open only to all interested bidders who have purchased the Bidding Documents.

All bids shall be accompanied by a **Bid Security which shall be limited to Bid Securing Declaration and at least one (1) other acceptable form in accordance with the amount stated in ITB Clause 18.1.** Bids shall be opened in the presence of the bidders or their duly authorized representatives provided that he/she has with him/her a Special Power of Attorney (SPA) duly executed by the owner of the Company. **Late bids shall not be accepted.**

To bid this contract/s, an interested bidder must submit the following Eligibility Requirements: Registration Certificate from SEC, DTI or CDA, Valid/Current Mayor Permit, Tax Clearance, Statement of all Ongoing Government & Private Contracts Including contracts awarded but not yet started, Statement of Single Largest Completed Government or Private Construction Contracts which is similar in nature and complexity to the contract to be bid, Valid PCAB License & Registration, Audited Financial Statements showing the Bidder's total and current assets & liabilities and Computation for its NFCC. Interested Bidders with lacking any of the eligibility requirements shall be a ground for automatic disqualification.

The PNP PRO 8 reserves the right to accept and reject any Bid, to annul the bidding process, and to reject all bids at any time prior to the contract award, without thereby incurring any liability to the affected Bidder/s.
