INVITATION TO BID/REQUEST FOR EXPRESSION OF INTEREST

The PNP PRO 8, through the **GAA FY 2018** the sum of **Php 4,891,878.79** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of TCPO Police Station 2 Building**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The PNP PRO 8 now invites bids for the Construction of TCPO Police Station 2 Building, a two-storey building with roofdeck having dimensions of 12 meter-length and 8 meter-width. Completion of the Works is required with contract duration of one hundred eighty (180) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested Bidders may obtain further information from PNP PRO8, through its BAC Secretariat, Office of the Regional Logistics Division (ORLD), Camp Kangleon, Brgy Campetic, Palo, Leyte and inspect the Bidding Documents from 8:00 AM to 5:00 PM.

A complete set of Bidding Documents shall be purchased by interested Bidders from PRO8 BAC Secretariat, ORLD and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (P5,000,00)** to be paid at the Regional Finance Service Office 8.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and website of PRO 8, provided that the bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The PRO8 BAC will hold a Pre-Bid Conference on **February 22, 2017 at 09:00 AM** at Matapat Board Room, which shall be open to all prospective bidders.

Bids must be duly received by the BAC Secretariat to the address below on or before **March 6, 2018 at 09:00 AM** at PRO 8 BAC Secretariat, ORLD, Camp Kangleon, Brgy. Campetic, Palo, Leyte. All bids must be accompanied by either Bid Securing Declaration or any acceptable forms of Bid Security in the amount stated in ITB Clause 18.1. Bids will be opened in the presence of the bidders or their duly authorized representatives provided that he/she has with him/her a Special Power of Attorney (SPA) duly executed by the owner of the Company. Late bids shall not be accepted.

To bid this contract, a prospective bidder must submit the following Eligibility Requirements: SEC (Corporation), DTI (Sole Proprietorship) or CDA (Cooperative), whichever is deemed appropriate; Valid and Current Mayor's Permit; Tax Clearance; Statement of all Ongoing Government & Private Contracts Including contracts awarded but not yet started; Statement of Single Largest Completed Government or Private Contracts similar in nature and complexity or has the same major categories of work to the contract to be bid; Valid PCAB License & Registration; Audited Financial Statement showing the Bidder's total and current assets & liabilities and the Computation of its NFCC. Bids that fail to include any of the above-mentioned eligibility requirements or are missing, incomplete or patently insufficient shall be considered as "failed".

The PNP PRO8 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
